



#### Functions of the Teaching Council | Matatū Aotearoa

- Pou Here Tōmua establishing and maintaining standards for initial teacher education and undertaking Initial Teacher Education programme approvals
- Pou Whai Rēhitanga becoming registered and certificated as a teacher
- Pou Mataara ensuring high-quality teacher practice
- Pou Matatika ensuring high standards of ethical behaviour
- Pou Tikanga Matatika, Ngā Paerewa establishing and maintaining the Code of Professional Responsibility and Standards for the Teaching Profession
- Pou Aro Whakamua steering the future direction of teaching



# Te Whare o Rongotauira Māori medium Initial Teacher Education Programme Approval, Monitoring and Review Requirements.



- Te Reo Māori Immersion (Māori medium) and Kaupapa Māori Initial Teacher Education (ITE) programmes
- ITE requirements reside within the dimension of Te Whare o Rongotauira

### ITE monitoring:

- Interim monitoring occurred over 2021-2023
- Monitoring has been reconsidered in light of 2019 ITE Requirement by a Monitoring, Review and Moderation working group
- The new monitoring processes to be implemented over 2024
- The new processes place a premium on efficiency, low burden and high trust.

# Student exemptions via ITE portal:

- Language competency
- Exceptional academic entry for international students into graduate/post-graduate programmes.

(Most other 'exceptional cases' are dealt with through your programme's own approved policy.)

- Free of cost


